Vermont Agency of Natural Resources SFY 2012 Ecosystem Restoration Grants

As part of the Department of Environmental Conservation's (DEC) on-going efforts to reduce surface water pollution from phosphorus and sediment, the fiscal year 2012 state budget includes capital funds to support ecosystem restoration projects. DEC is currently seeking project pre-proposals due by July 15, 2011. Typical project budgets range between \$10,000 and \$75,000. DEC is specifically interested in proposals designed to improve water quality, including but not limited to projects that:

- improve stream stability
- incorporate the science of fluvial geomorphology in river corridor management decisions
- protect against flood hazards
- improve in-stream and riparian habitat
- mitigate the effects of stormwater runoff from developed land areas
- promote low impact development practices
- protect and restore riparian wetlands
- re-establish lake shoreline native vegetation and related shoreline erosion corrections
- directly address in-lake (internal) phosphorus loading conditions
- enhance the environmental sustainability of agricultural lands

The goal of the Ecosystem Restoration Grants program is to reduce the long-term nutrient and sediment loading from, and/or increase nutrient and sediment storage in, Vermont watersheds.

Pre-proposals should be submitted in electronic format (PDF preferred), clearly marked, and emailed to Heather Bullett (heather.bullett@state.vt.us). The deadline for submission is 4:00 pm on Friday, July 15, 2011. Planning for Economic Development: New Local & Regional Requirement

With legislation passed this year, for the first time, both local and regional plans must contain an economic development element, or chapter. While economic development planning was imbedded throughout the enabling statute in the goals and within the plan structure language, separating it out elevates the importance of this facet of planning. As the state embarks on new statewide economic development planning, it is essential that municipalities and regional planning commissions integrate economic development planning with our land use, transportation, infrastructure and housing planning.

Many local plans in our region already contain something that meets or partially meets these new requirements. The effective date of these new requirements is July 1, 2012 which means that any *local or regional plan adopted after that date must contain the new element*. This delayed effective date allows us the time we need to align our planning to meet the statute and Legislative intent.

Northwest Regional Planning Commission is available to work with each of our towns to address these changes. Other partners and stakeholders will undoubtedly offer their assistance or advice as well, including Franklin County Industrial Development Corporation, Lake Champlain Islands Chamber of Commerce and Franklin County Chamber of Commerce.

24 V.S.A. § 4382 **(new language is underlined)**

§ 4382. THE PLAN FOR A MUNICIPALITY

(a) A plan for a municipality may be consistent with the goals established in section 4302 of this title and compatible with approved plans of other municipalities in the region and with the regional plan and shall include the following:

(11) An economic development element that describes present economic conditions and the location, type, and scale of desired economic development, and identifies policies, projects, and programs necessary to foster economic growth.

Department of Fish & Wildlife Summer Webinar Series

NRPC will be hosting the DFW's summer webinar training series for RPC staff, town staff and other interested parties. There are four sessions planned throughout the summer. If any of the events below interest you, feel free to join us in our conference room on the following dates:

1. **Tuesday 6/21 from 10:30 - 11:30 Habitat Blocks & Connecting Lands;** This webinar will begin with an in-depth description of how habitat blocks and wildlife road crossings datasets were made, while the second half will focus on their uses in a planning context. 2. **Tuesday 7/5 from 10:30 to 11:30 Deer Wintering Areas and the Vermont State Wetlands Inventory;** Fish & Wildlife Biologists have revised the older version of the deer wintering areas dataset. The first half of this session will focus on this new data release, how it was done, and how to use it appropriately in a planning context. The State Wetlands office has recently updated the Wetland Rules and made changes to the Vermont State Wetlands Inventory (VSWI) to include more wetlands than previous versions. 3. **Tuesday 7/19 10:30 – 11:30 a.m. Town Plan Review;** Vermont Natural Resources Council has completed a review of all town plans and municipal bylaws in the state with respect to their treatment of fish & wildlife resources. This session will highlight the major findings of the report and discuss implications for how municipalities can continue to strengthen planning for fish and wildlife conservation. 4. **Wednesday 8/17 10:30 – 11:30 a.m. Subdivision Trends;** Vermont Natural Resources Council recently studied Grand List data from 2003 and 2009 to establish a database of parcels of land in the state, compiled by class size, to quantify the extent of subdivision over the last decade, and the degree to which subdivision is affecting the long-term viability of forestland in Vermont. Ellen Kahler, Executive Director of the Vermont Sustainable Jobs Fund, will present an overview of the report's findings and discuss specific resources and opportunities of interest to the Northwest Region. The event is co-sponsored by the Northwest Regional Planning Commission, the Franklin County Industrial Development Corporation, the Franklin - Grand Isle Workforce Investment Board, the Grand Isle Industrial Development Corporation, and the Franklin County Chamber of Commerce.

From the Farm to Plate Strategic Plan Executive Summary:

In the past 10 years, a growing movement in sustainable agriculture—involving increased local food production and consumption, value-added processing, and diversified farms—has taken off. During the 2009 legislative session, two member-based public policy organizations, Vermont Businesses for Social Responsibility and Rural Vermont, crafted and helped win legislative approval for the creation of a Farm to Plate Investment Program (F2P). It was approved by the Senate and House in May 2009 and signed by Governor Douglas, as Sec. 35. 10 V.S.A. chapter 15A § 330. The legislation tasked the Vermont Sustainable Jobs Fund (VSJF), in consultation with the Vermont Sustainable Agriculture Council (SAC), with crafting a strategic plan based on a broad scope of work.

The primary goals of the legislation are to:

1. Increase economic development in Vermont's food and farm sector.
2. Create jobs in the food and farm economy.
3. Improve access to healthy local foods.

A key goal of the F2P plan is to identify infrastructure investments and public policy recommendations that will support new and existing agricultural enterprises that increase local resiliency in today's changing times. There are both historic and recent threats to the future of agriculture in the state, including the loss of dairy farms, rising energy and feed costs, the volatility of commodity markets, global competition, and climate change. There are also many signs of expansion and opportunity, especially for diversified and organic farm operations as the model of industrial agriculture faces increasing public scrutiny.

The F2P Plan's ultimate purpose is to encourage policies and strategic investments that accelerate the movement toward strong local and regional food systems. Regional Technology Teams Plan to Maximize Use of Broadband

Regional Planning Commissions across Vermont are currently assembling Regional Technology Teams made up of stakeholders who can envision what life could be like with universal high-speed broadband availability. Local government, schools, business, non-profits, and others will work together to implement strategies for using broadband access to enhance Vermont's way of life.

Each Regional Technology Team will develop a strategic plan that identifies needs and opportunities related to new technologies, provide strategies to drive adoption of broadband, identify key partnerships that will benefit from the coordinated use of information technology (such as government services, education, health care, business, etc.) and set targets for improvement among those key partnerships.

Participants will also identify broadband technology gaps, set achievable goals for improving use, and convene local & regional events to inform the public about Regional and State Telecommunications Plans. The Regional Technology Plans will be used by state, regional and local officials, including the Vermont Telecommunication Authority.

Northwest Regional Planning Commission's Technology Team will hold its first meeting at the end of June. Ruth Wallman of the Lake Champlain Island Chamber of Commerce, a member of the team for Franklin and Grand Isle Counties said "This is a great opportunity to build on our strengths and use universal broadband access as a tool to enhance education, tourism, industry and community."
