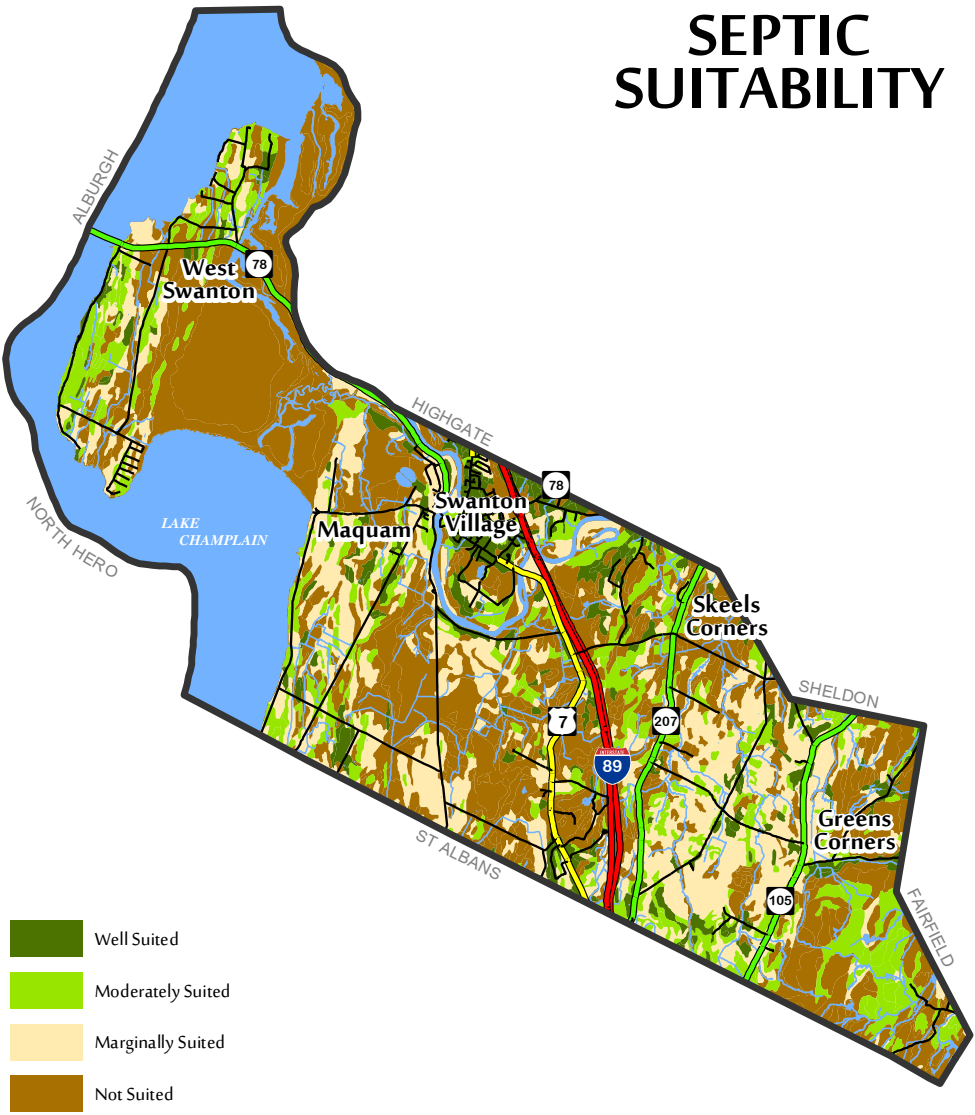


PUBLIC WATER SUPPLY SOURCE PROTECTION AREA



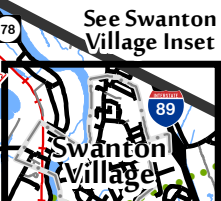
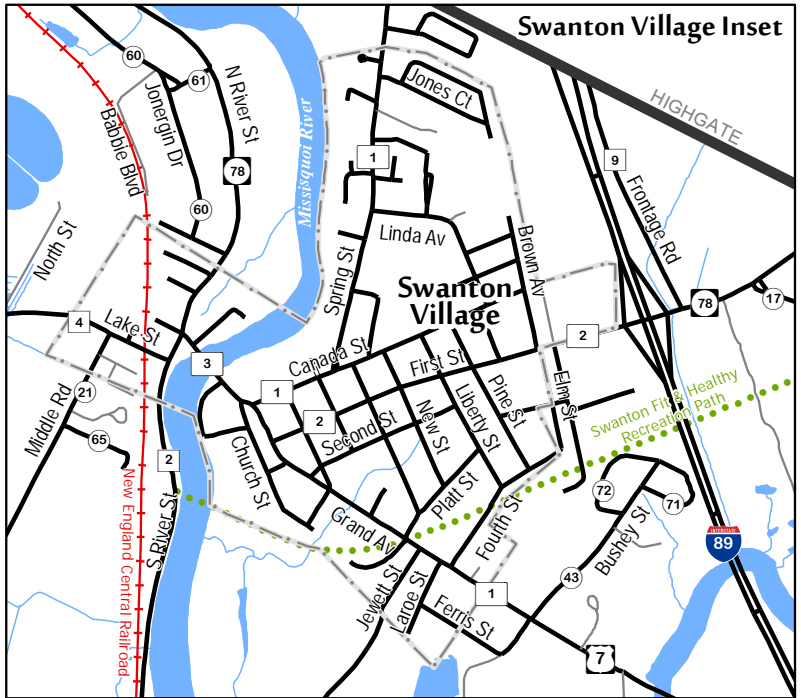
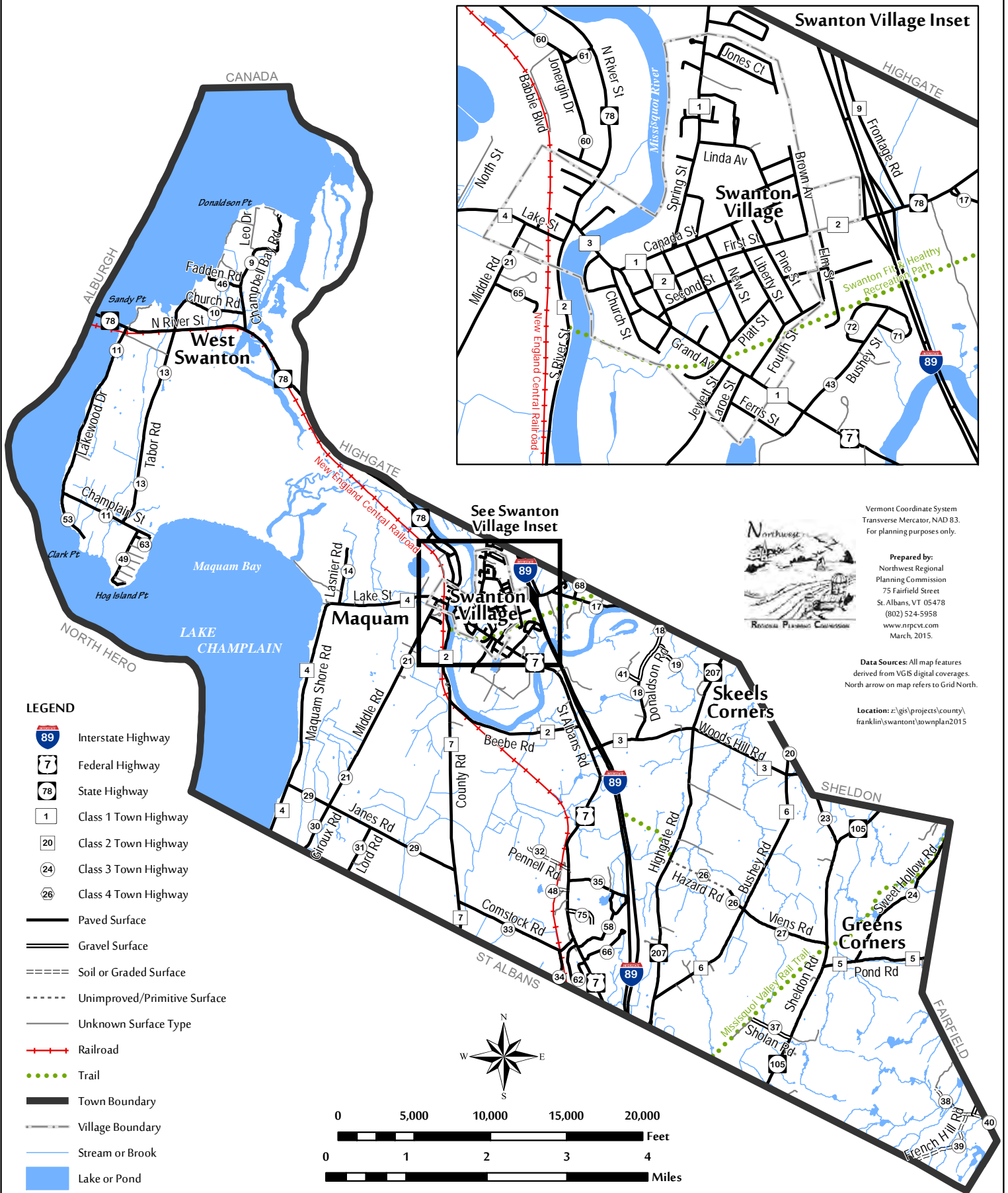
